Your Visa Debit Card is also an ATM card giving you access to your METRO accounts 24 hours a day. Get cash or your account balance, transfer between savings and checking, or make a deposit (at participating ATMS).

On an individual account basis the following withdrawal limits apply:

- The daily limit for Visa purchases is based on your available collected balance in your checking account.
- ATM cash withdrawals are limited to \$500 per day and Point of Sale (POS) purchases to \$2,000 per day.
- Note for Visa Transactions: When you have authorized a transaction, an "account hold" in the amount of your purchases will be set on your account and will reduce your account balance for eligible withdrawals. Once the transaction is processed the hold is removed from the account.

Transaction Fees:

- NO transaction fees for VISA POS purchases.
- Deposits made at ATM machines are Free at participating ATMs.
- Withdrawals, Transfers, and Inquiries are \$1 each (Some ATM machine operators may impose a surcharge on cash withdrawals).
- All ATM withdrawals, transfers and inquiries are FREE when you use it at our METRO ATM!
