

OFFICIAL METRO FEDERAL CREDIT UNION IPAD PRO GIVEAWAY RULES

PRIZE: The prize awarded to the randomly selected winner will be an iPad Pro 10.5" 256GB. Any prize notification or prize that is unreturned, or winner unresponsive, will be awarded to an alternate winner. The winner accepting the prize agrees that the prize is awarded on the condition that METRO Federal Credit Union, and its agents, representatives, affiliates and employees will have no liability whatsoever for any injuries, losses or damages of any kind resulting from acceptance, possession or use of the prize. Winner may not make any substitutions or transfers of any prize.

NOTIFICATION: Winner will be notified by phone and email. Before claiming prizes, winners must sign and return a release, which must be received when winner claims prize in person at METRO Federal Credit Union. Winner must show picture identification to claim prizes. METRO Federal Credit Union reserves the right to examine additional identification and may choose to accept or deny awarding the prize based on the identification presented.

ENTRIES: Enter the raffle by meeting or completing one, or more, of the following conditions:

- (a) Purchase a raffle ticket at METRO Federal Credit Union for \$10.00;

 - a. To qualify for this option, account must be opened by a new member. Existing members with a current savings and checking account do not qualify.
